Findings indicated that TU staff played a crucial role in administrative, financial, and daily operational management, while information technology integration contributed positively to efficiency. Challenges such as resource limitations became a focal point of discussion. The results of this research provide a foundation for the development of best practices and policies at the elementary school level. Future prospects involve a deeper understanding of information technology implementation and TU professionalism. Further studies can explore broader impacts on educational quality and contribute positively to the elementary education system in Indonesia

Despite increasing awareness of the importance of the role of TUs, the lack of a deep understanding of their concrete impact on the implementation of efficient governance remains a relevant issue. The study by Hasan highlights that although TUs are often identified as key players in school administration, more research is still needed to detail their impact holistically. This research can help explore the complex dynamics of the role of TU, including the challenges and opportunities it may face (Hasan, *et al.*, 2021). Therefore, further efforts are needed to gain a deeper understanding of the role of TU in the elementary school environment in order to optimize its contribution in supporting efficient and sustainable governance at the basic education level.

Several studies have highlighted crucial aspects related to the role of Administrative Services. Research by Sulaiman & Widianti shows that the professionalism and competence of Administration staff have a direct impact on the efficiency and effectiveness of school operations (Sulaiman, & Widianti 2019). The results of the study emphasize the importance of investment in training and development of administrative staff to improve the quality of administrative and managerial services in the school environment. In addition, findings by Setiawan *et al.* highlighting the importance of the application of information technology in school governance. The collected qualitative data is processed using a thematic analysis approach. This process involves coding, organizing, and analyzing data to identify patterns, key findings, and relationships between concepts (Miles, & Huberman, 2021). Validity is maintained through triangulation of data from multiple sources (interviews, observations, document analysis), while reliability is strengthened through a clear and consistent analytical framework (Creswell, 2021). Ethical aspects of research are a top priority, including obtaining permission from the school and ensuring the confidentiality of participant data. Each participant was asked to sign a consent form before engaging in the study. The overall methodology is expected to provide deep and meaningful insights into the role of Administrative Services in supporting efficient governance in Primary Schools.

3. RESULTS AND DISCUSSION

quality professionalism and competence can have a positive impact on overall school governance. The alignment of findings with previous research shows the consistency and relevance of the results obtained, reinforcing the conclusion that the role of TU has a sustainable impact on the efficiency and effectiveness of school operations and efficient governance.

The importance of the role of Administrative Services (TU) as the main pillar in supporting the implementation of efficient governance in elementary schools (SD) is reinforced by the findings of previous research (Sulaiman, & Widianti, 2019). The research confirms that the professionalism, competence, and strategic role of TU create a solid foundation for improving the quality of school governance. These findings align with research by Yusuf and Sumardi that highlights the key role of TU in administering school administration and having a direct impact on school performance (Yusuf, & Sumardi, 2020). Furthermore, good leadership from TU not only affects daily operations but also contributes positively to the overall school atmosphere, in line with Prayitno's research which shows that TU leadership plays an important role in creating a conducive learning environment (Prayitno, 2019). By referring to the research of Yusuf and Sumardi and Prayitno, this study reinforces the view that the role of TU goes beyond administrative tasks, but also makes a vital contribution in building an optimal quality of school governance.

B. Challenges and Opportunities of Information Technology Integration in Administrative Services

Document analysis shows that the integration of information technology in the school administration system contributes positively to the efficiency of Administrative Services. Integrated information systems are proven to provide convenience in data management, enable a more efficient report generation process, and increase the level of information transparency in schools. With the adoption of advanced information technology, TUs can be more effective in carrying out their administrative tasks, speeding up workflows, and providing easier access to necessary data.

This result is in line with the findings of Setiawan *et al.* who highlight the importance of information technology integration in improving the efficiency of Administrative Services in the school environment. This integration not only modernizes administrative processes, but also contributes significantly positively to the overall operation of the school (Setiawan, *et al.*, 2020). The statement stressed that the integration of information technology in school administration systems has greater implications than simply modernizing administrative processes. In addition to improving efficiency in administrative tasks of the Administrative Service, this integration also contributes significantly positively to the overall operation of the school. This can include improving data accessibility, speeding up decision-making, and increasing transparency in various aspects of school activities. In other words, the integration of information technology is not just about improving operational efficiency but also creating a broader positive impact on the overall functioning and performance of the school.
